



Interrogation Instructions

You can interrogate each of the four suspects.

- Review the guide below to learn techniques and guidance.
- Review *Suspect Profiles* to read written statements and relevant facts about each suspect
- Suspect profiles can also help link evidence to specific suspects, e.g. shoe size, blood type, car make & model etc.

KEY NOTE

**Only one person is guilty of stealing Anti-Matter!
Try to rule people out!**

Technique 1

Hide evidence you know and set a trap

Sample Question 1

"Were you ever at the crime scene?"

- Suspects do not know if you have evidence linking them to the crime scene or not, they are forced to weigh the decision of whether to lie or tell the truth.
- The more questions you ask like this the more chance of catching them in a lie.
- Camouflage the question you really want to know. If you come out and ask only one question it gives suspects a major clue what you're trying to do.
- Make sure you record the answers suspects give you so you can cross check as more evidence comes to light.

Use Evidence to Break Suspects

Suspects can lie and hide information. You can use evidence to break them and get important additional facts!



Organize Evidence by Suspect

Evidence only matters if it is attached to ONE of the four suspects.

Technique 2

Tell them evidence and demand an explanation

Sample Question 2

"We have prints that place you at the crime scene, why were you there?"

- This question reveals the evidence you have, but also demands an explanation.
- This can help you to eliminate suspects that have a believable reason, and/or put the guilty person on the spot.
- Use this technique to obtain additional information which you can confirm or deny.

Key Suggestions

- You are interrogating 3 people who are innocent of this crime and may have helpful information.
Try as hard to prove suspects' explanations are true as you do to disprove them.
- Listen to what suspects say and try to put the story together as it actually happened. Presumably, three of the stories should match and one should be inconsistent.
- **Focus on using the evidence you have, and new evidence as it appears, to get more answers.**

Scripted questions for each suspect to get you started.

Dominique

"Can you highlight the things that were unusual or different about today versus most days? Try to be specific."

"Why did you give Ethan a bottle of wine?"

"Does Ethan normally ask you to get food for him?"

"Did you see anyone leave Ethan's office?"



Ethan

"Explain in detail why Rolph was in your office when the power went out?"

"Describe your relationship with Rolph and Vivian"

"Did you sign a work order?"

"Why didn't you eat the danish Dominique got for you?"



Rolph

"Explain in detail why you were in Ethan's office when the power went out?"

"Do you have anything you would like to disclose now, for example, something we might find in your locker?"

"Do you have any proof of your story?"



Vivian

"Where were you today at the time of the theft?"

"Describe your relationship with Rolph and Ethan"

"What size shoe do you wear? Our records say a Women's size 10, is that correct?" "Do you know your blood type? Could you share that with us?"

"Did you want to implement the new security protocols early?"

SUSPECT PROFILE

Dominique



Dominique has worked for 10 years with Ethan as his executive assistant. She knows him better than anyone else in his life. She has Level 1 security access which means she has a spotless record and any transgressions will lead to her immediate firing. She greets every person before they are allowed to enter Ethan's office. She works out regularly at the company gym before lunch. Normally no one is allowed to visit Ethan during this time.

Means: Dominique has regular access to Ethan's office although he must be present in the office and enter a code to allow her to enter. She would have had possible access as Rolph was leaving the office and the door was momentarily open.

Motive: 1 billion dollars

Opportunity: Dominique was present at Ethan's office and no one else was around to verify where she was or what she did. Neither Ethan nor Rolph made any statement as to her presence.

Official Statement

Dominique claims she hid under her desk when the power went out as per the employment handbook protocol. She did not hear Rolph leave although she says there was a commotion going on in Ethan's office and she was somewhat disoriented. Her position under the desk would have allowed Rolph to pass unnoticed if he was efficient.

- She did not see Rolph enter the office as she was working out during her 45-minute lunch break (11:45AM to 12:30PM).
- She said Ethan came out after the power went back on and told her to call security.
- She says Ethan then went down the hall for a couple of minutes before the paramedics got there to look at his wound.
- This was her first day with her new HP LaserJet Enterprise X Printer. She is the first and only person in this hemisphere to have one. It is a new model in beta, being tested in elite circles.

Suspect Profile

Ethan



Ethan has been with MatterMatters for 10 years and has worked his way up to be CEO of the company. He is known as the steward of “Antimatter”. Ethan has stock options in MatterMatters valued at over 50 million dollars and draws a \$1,000,000 annual salary. The theft of Antimatter provides an enormous insurance payout to MatterMatters over \$500 million, far short of the long-term value to the company: the upper end is unknown.

Means:

Ethan has all the means to steal the Antimatter. Complete access at the time of the theft.

Motive: 1 billion dollars + onetime payout from MatterMatters of 50 million if it is stolen.

Opportunity: Ethan had opportunity to steal the Antimatter except he claims to be unconscious at time of theft. He has a fresh wound on his head consistent with being stuck by a hard object. The safe will only open when he is in his office, even when the power goes out.

Official Statement

Ethan claims

- Rolph showed up unexpectedly at his office around 12:15 PM and asked to be let in to fix a high security breach in the electronic monitoring system.
- Ethan asked him to come back when Dominique returned but Rolph insisted his task was “extraordinarily time sensitive”.
- Ethan let him in and shortly afterwards the power went out. The next thing he remembers was waking up and seeing the safe closed and locked down and then he walked out of his office and had Dominique call security immediately.
- He claims he did not touch or alter anything from the time he went unconscious to the time when security arrived.
- The last time the safe was open was when he initialed and placed some official documents into the safe and closed it at 9:30AM. Dominique witnessed him signing the documents. He used his custom OVI pen which he keeps inside the safe. The Antimatter was inside the safe at that time as well.

SUSPECT PROFILE

Rolph



Rolph is a high-ranking facility engineer assigned to maintenance in the ultra-secure Level 1 security zone. He has worked at MatterMatters for 21 years with a spotless record. The only way to get Level 1 access is to have a 100% clean employment and criminal record, and employees are fired immediately for any transgressions, however small. Witnesses say Rolph is a reliable family man with three kids and a wife of 25 years.

Means: Rolph was inside Ethan's office when the power went out – a highly unusual situation because the safe opens one time in a power outage **only** when Ethan is present in the office. This allows Ethan the opportunity to place important items inside the safe – or to remove materials from the safe - in case of emergency. Once he closes the safe it cannot be reopened without a 3-person security protocol and power.

Motive: 1 billion dollars

Opportunity: Rolph was present in the dark, in the same office with Ethan, with the safe open. Ethan claims someone hit him on the head and knocked him unconscious, and then took the Antimatter before he could close the safe.

Official Statement

Rolph claims that

- Ethan called Rolph personally into his office to adjust his chair correctly.
- When he arrived he had Ethan sign the requisite work order, and then placed the order on Ethan's desk.
- While he was adjusting the chair, Ethan left to use the washroom.
- When Ethan returned he asked Rolph to test the safe handle and make sure it felt right. As he knelt and grabbed the safe handle with his hand, the power went out.
- Ethan asked Rolph to leave immediately and go to the subbasement to find out what the problem was.

SUSPECT PROFILE

Vivian



Vivian is a high-ranking member of the security department at MatterMatters and prides herself on her physical abilities. She is trained in personal defense, enjoys rock climbing, and is very popular with the opposite sex. At 6 foot 2 she commands respect and is a formidable adversary to any who consider breaking the rules within the confines of corporate headquarters. Witnesses at the company say she has been working on a confidential security protocol directly with the CEO, Ethan.

Means: Vivian has access to all the top-level security protocols within headquarters. Although she does not explicitly have access to Ethan's office, it is conceivable she could figure out a way to enter; especially with the power being out. She is trained at counterintelligence for crimes just as this one. She has had extensive access over the last 6 months to the highly secured office. It was her week off, so she was not allowed to be on campus. A strict security protocol states that no employee is allowed on campus during any non-work time; immediate firing is the consequence.

Official Statement

Vivian says

- She was jogging by herself at the time the theft occurred. It was her week off.
- She did not know anything more about Rolph than the standard security screening for all employees that work with the level 1 security zone.
- She knew Dominique only from her going into Ethan's office: "small talk".
- She had developed a close professional relationship with Ethan. For the past 6 months they had been working together on a sensitive and confidential security protocol in the event AntiMatter was ever stolen. The Security Protocol was to be finished next week.
- Her last visit to Ethan's office was the day before.
