- Ask specific questions you need answered by one or more of the suspects.
- Use evidence against suspects to get new information.



OVI Security Pens are designed to give a unique signature for VIPs by creating a customized, one-of-a-kind, ink formula that is both invisible to the naked eye and 100% unique to the stakeholder. They stand in court as a near 100% reliability source in terms of authenticating very important signatures.

Owners invariably keep them inside a high security safe at all times, and usually only remove them when signing important documents.

ANTI-MATTER



Aneimatter has many lucrative uses as it is an extremely powerful energy source and extremely rare.

It can be used as a weapon that uses antimatter as a power source, a propellant, or an explosive.

Antimatter weapons are rare due to the cost of production and the limited technology available to produce and contain anti-matter in sufficient quantities

Antimatter production and containment are major obstacles to the creation of antimatter weapons. **Quantities measured in grams** are required to achieve destructive effect comparable with conventional nuclear weapons.

The basic equation governing the antimatter reaction is Einstein's famous $E = mc^2$, except with the slight modification $E = 2mc^2$.

- One gram of antimatter annihilating with one gram of matter produces
 180 Tera joules, the equivalent of 43 kilotons of TNT: 3x the power of
 the bomb dropped on Hiroshima!
- The container above was stolen from Mattermatters Inc. containing 20 grams of pure Anti-Matter; enough to make 20lbs of weapons grade Anti-Matter material: THAT IS OVER 9,000 GRAMS OF WEAPONS GRADE ANTI-MATTER

CURRENT STATUS:

After an extensive search no trace or sign of the Anti-Matter has been found on premises.

After extensive interviews and records review it has been determined that the Anti-Matter likely left the building on someone's person, or through the plumbing. The building went into complete lockdown at approximately 12:39 PM.

A plumbing crew was granted access to the facility at 11:25 AM and was recorded leaving at 12:38 PM. Records show work in the Sub-Basement and on areas near Ethan's office. We have yet to determine the identity of the plumbing crew.
